Trading partner registration

Q1: How do I become a trading partner with DWC?

A1: Here are the steps:

- Register by going to the *Registration Instructions* link under the *Trading Partner Profile* section at https://txdwcedi.info/https://txdwcedi.info/
- DWC will approve your registration or ask for corrections. If denied a reason will be given.
- Send test files to Verisk. For more information about testing, got to *Implementation Info* in the *EDI Resources* section at <u>https://txdwcedi.info/</u>
- DWC will review and approve results of testing. If denied a reason will be given.
- Start filing live reports.

Q2: How do I register as a Trading Partner?

A2: Register online by going to <u>https://txdwcedi.info/ https://txdwcedi.info/register</u>. See the *Trading Partner Profile* section for the registration link and instructions on how to register.

Q3: I am a licensed Third-Party Administrator in Texas that provides claim administration services for many carriers. Can I create one trading partner profile under my name and then

list all my carrier clients?

A3: Yes. You should register as the trading partner and list each of your carrier clients in the *subsidiary Insurer* section of the trading partner online registration.

Q4: How do I send Claim EDI to the Texas DWC on or after July 26, 2023?

A4: There are three ways to send Texas Claims EDI 3.1.4 reporting. Select one of the following during trading partner registration:

- 1. **EDI Vendor:** by using a third-party EDI service vendor to submit EDI transactions on your behalf. Testing is required.
- 2. **Direct SFTP:** by connecting to a Verisk-hosted Secure File Transfer Protocol (SFTP). Testing is required.
- 3. **TXDWC Web entry:** by direct manual entry of each FROI or SROI report using a Verisk application. Testing is not required.

Q5: Who is eligible for **TXDWC Web entry**? Is there testing? Is there a cost? A5: Trading partners that do not have a vendor and that file 100 or less Claim EDI transactions per year are eligible for **TXDWC Web entry**. Access to the system will be provided prior to Production. Testing is not required for web entry. There is no cost.

Q6: Where do I find information concerning IAIABC EDI license fees? A6: EDI licensing fees are provided on the IAIABC website at <u>https://www.iaiabc.org/licensing</u>.

Testing

Q1: What is testing?

A1: Testing is a process used to determine whether you can send and receive EDI reports from the DWC.

Q2: What is the purpose of testing?

A2: Testing serves two purposes:

- 1. To ensure that all parties involved can transmit, receive and process Claim EDI in their systems.
- 2. To ensure that Claim EDI reports meet Texas Claims EDI 3.1.4 reporting standards.

Q3: What kinds of transactions will I be required to send during testing?

A3: You will be required to send different kinds of First Report of Injury (FROI) and Subsequent Reports of Injury (SROI). See the *Texas Claim EDI Release 3.1.4 Test Plan* for more information about testing.

Q4: When will testing start? A4: Testing will start on January 12, 2023

Q5: When will testing end? A5: Testing will end on July 18, 2023 Q6: Who is required to test?

A6: Trading partners that file using an **EDI Vendor** and those that that file using **Direct SFTP** are required to test.

Q7: Who is not required to test?

A7: Trading partners approved to file using the **TXDWC Web entry** are not required to test.

Q8: I was approved to use the **TXDWC Web Entry** system. Can I voluntarily test? A8: Yes, you can voluntarily test. Please contact the TXDWC EDI Support Team if you would like to voluntarily test.

Q9: What kinds of acknowledgments (AKC) will I receive during testing?

A9: You may receive one of two kinds of acknowledgements:

- 1. **Valid Batches:** If the file and format of the batch are valid, you will receive an acknowledgment with details about the transaction(s) within the batch.
- 2. **Invalid Batches:** If the file or format are invalid, you will receive either a batch rejection acknowledgment or you will be contacted by the DWC support team to discuss the file structure or format issue.

Q10: What is the **Texas Claims Release 3.1.4 EDI Testing List** used for?

A10: Use the testing list to track in formation about all the transactions that have passed. This list will be provided to the DWC after you complete testing.

Q11: How will I know whether a transaction within a batch has passed Texas Claim EDI 3.1.4 edits and requirements?

A11: The status of each transaction will indicate:

- Passed = TA Transaction Accepted
- Rejected = TR Transaction Rejected
- Passed with errors = TE Transaction Accepted with Errors

Q12: What do I do with TR or TE that I receive during testing?

A12: If the transaction resulted in a TR, the transaction must be corrected and sent again. If the transaction resulted in a TE, an MTC CO must be sent with the corrected information on it. The Maintenance Type Correction Code and Date must be present. The Maintenance Type Correction Code is the MTC of the transaction that received the TE. The Maintenance Type Correction Code Date is the MTC Date of the transaction that received the TE.

Q13: How will I be notified that I successfully completed testing?

A13: If your test transactions meet or expected quality requirements, DWC will notify you via email that testing has concluded and that you have been approved for *Production* batch filing.
